Any additions or alterations to the exterior of your property require submission of your proposal or plans to the ARB for review and approval before proceeding with any work.

- (a) ARB Owner Agreement (required for all submissions).
- (b) A site plan showing all proposed alterations of topography and the dimensions and location of all existing and proposed buildings, fences, walks, utility easements, setbacks, wells, septic tanks, and leach field or other improvements to be erected on or under such lot (required for all submissions except paint).
- (c) Floor plan and exterior elevations of all structures (including the dimensions thereof) as they will actually appear after all changes are done.
- (d) The description of the exterior materials to be employed in all Structures.
- (e) The date the owner intends to commence such work and the date such work shall be completed.

approval, some of the work listed above may require city permits, inspections, and shall be subject to all applicable governmental laws, statutes, ordinances, rules, orders and decrees. Processing of ARB requests will take no more than 15 days from completed application and receipt of all supporting documents. Please allow sufficient lead time for your project's review by the ARB. **No work may be scheduled until written ARB approval is received.** Any work performed without ARB approval will be subject to fines and may require removal of work and restoration of property to its prior condition.

- ⤴ The authority to perform an alteration granted by this application will automatically expire if the work is not completed within 12 months from Architectural Review Board approval.
